CONTRACT POLICIES:

1. Contract ice time is first come, first serve. Sessions are full at 20 skaters each. Skaters requesting sessions that are full will be notified and offered a transfer or credit.
2. ONLY contracts received on or before the close of business on the LAST DAY of the preceding month will receive the 15% discount.
3. An unlimited number of session transfers are allowed per skater providing a) sessions are transferred within the current contract month b) the request to transfer sessions is submitted in writing to the Skating Director twelve (12) hours prior to the cancelled session. You may request session transfers via e-mail to **Jessie@tulsaoilers.com**. Session transfers are at the discretion of the Skating Director.
4. Refunds and credits will not be given for any unused sessions. However, skaters medically required to refrain from skating, due to injury or illness lasting **more than 3 days**, may request credit for unused sessions providing a) the request is submitted in writing to the Skating Director no more than 24-hours after injury b) a medical note is submitted with the request. You may request session credit via e-mail to **Jessie@tulsaoilers.com** Refunds and credits are at the discretion of the Skating Director.
5. Sessions purchased after the contract deadline will be charged the current walk-on rate.
6. Oilers Ice Center reserves the right to cancel or reschedule sessions that do not fill. Refunds and credits will be given for sessions cancelled by Oilers Ice Center.
7. Contracts will only be accepted when accompanied by full payment and the waiver/release of liability has been signed.

Freestyle Rules and Ice Etiquette

1. Skaters are required to pay and/or sign in for their session before stepping on the ice.
2. Skaters MAY NOT enter the ice until the start of their designated session. Skaters entering the ice earlier than their designated session will be charged for that session.
3. Skaters carrying a past due balance with the rink WILL NOT be allowed on any session until pay in full.
4. Skaters are to enter and exit the ice from the north door located by the player's benches. The south door is to remain closed during all sessions.
5. Skaters are allowed only water on the ice. Other foods and drinks must remain off the ice.
6. Ipods and MP3 players may not be worn during sessions.
7. Skaters are to refrain from the use of profanity.
8. Skaters are to respect the ice, coaches and other skaters.
9. Skaters are not to TALK, stand around, or play during freestyle session. These sessions are dedicated for practice and training only.
10. Skaters will only be allowed to leave the ice with permission from a coach.
11. Skaters "in program" have the right of way to the ice. All other skaters must yield to them and those in lessons.
12. Music will be played in the order it is turned in. Music must be played all the way through with no starting and stopping. Dance music may be played but only one dance per turn.
13. Coaches in lesson are allowed to cut other skaters music that is in line to be played.
14. PARENTS ARE RESTRICTED TO BLEACHERS AND LOBBY ONLY. Any parent observed instructing a skater, including using gestures from the viewing area will be asked to leave the facility. Parents may not stand behind the player's bench at any point during freestyle.

Skaters and parents not compliant with the rules and regulations of freestyle will be asked to leave the ice and /or facility.
